Directions to Applicant

- 1) You have Two (2) weeks to return your application from the date you picked it up with the following items.
- 2) A copy of your high school graduation certificate or a copy of your GED certificate must accompany your application when you bring it back.
- 3) A sealed, original high school transcripts. These *can not be copies and must be in a sealed envelope.*
- 4) A copy of your current valid, driver's license.
- 5) A copy of your birth certificate
- 6) Proof of Citizenship or Legal Alien Status
- 7) New apprentices will be sent out to jobs after completion of background check, drivers license screening and substance abuse testing

After your completed application is received, and all documents are reviewed, you will be notified of a mandatory standardized third party test. The cost of this test is \$30.00 and will be paid by you. (Correct cash amount only)

APPLICATION PROCESS

Step 1 – Apply in person on the second (2nd) Wednesday of every month between 12:00 pm and 4:00 pm

Step 2- Return completed application within two (2) weeks of when you picked it up with the following documents:

- 1) copy of your high school diploma or GED
- 2) copy of your valid Ohio drivers license
- 3) copy of your birth certificate, alien registration, work visa or other documentation that proves you may work in the United States
- 4) copy of your high school transcripts or GED test score

***Failure to provide the above required documentation prohibits you from going on to Step 3

Step 3- Take the 3rd party standardized test as approved by Local # 94 JATC

- If your score is a 70% or higher you will advance to Step 4
- If your score is below a 70% you will need to reapply to the program

Step 4- Test results will be mailed within one (1) month of test date

Step 5- Receive a letter with your personal interview date and time

Step 6- Interview will be at 3919 13th St SW Canton, Ohio 44710

** failure to appear for your interview will void your application and you will need to reapply

Step 7- Selection of apprentices.

** If you are not selected, your score will remain good for two (2) years from your personal interview.
